First time we met he was having a conference meeting with his wife about the dreams. I was taken by the dreams and I believed in them. He had come to our house for some reason and was just telling us things like dreams and stuff. Told us about ~~dreams~~^{bras} and underwear, (women) how he had a dream about them and how they are not good for womens health. He also talked about having a shaved vagina. That week I decided in changing. Got rid of bra, underwear, and I shaved my vagina. Later on, some months passed and I was called to be in a special group part of the ministry. This is when we had a church being funded by the ministry and it was in Apopka. I was told I had to walk around naked, eventually go to nudists resorts, wear no bras, or panties, and I had to eventually wear something

1. Petitioner claims the following about the home that Petitioner and Respondent share or that Petitioner left because of domestic violence:

called the "uniform". The uniform consisted of wearing tank tops and mini skirts. Usually white tank tops and we were not to be afraid of having our nipples show or pierce through. The same went with the skirt. When we would bend down, we shouldn't care if our vagina or butt shows. Cause we didn't wear underwear. I did that for a while. He was coming to visit in town, from California to Florida. We met in a nudist resort called Cypress Cove. My whole family went except my dad.

A year or maybe a few months later I had met my bf, my now husband on a chatting app in June. We got together September 22. In August Ernie had a new dream of me and how I was called to remain pure and undefiled. I was to represent the Pure Church. Meaning no boyfriends, sexual activity, etc. Although I knew that I kept contact with my soon to be boyfriend [REDACTED] In December there was another dream where I had broken all the rules but I was given another chance. My sisters had moved to California but they were there to

They were living with Ernie. I was told to cut ties with all my friends, including to cut ties with my boyfriend. I, again did not really listen to the instructions. I would go over my friends houses and I would go see [REDACTED] (bf) in secret. Everything blew up on my face because my dad, who we just left alone at home with no warning, did not believe nor accept the ministry. so we all basically packed up our stuff and disappeared from him without saying a word. No contact whatsoever. My dad had put a tracker in my car and followed me all the way from Apopka to Clearwater. Abt a 2hr drive. I panicked and called the police and that got him away. My dad spread the news that I was at an older mans house. My boyfriends house. That news spread to my mom and everyone. Two days later there was another dream about me.

During this time, my sister was with Ernie in Jamaica. so they facetimed the dream. I was told I had sinned that God was going to put me to be a prostitute but then He changed His mind and I then became the 7th wife.

I was told I had to leave on the 27th of May, which was 3 days after the dream. My mom was instructed to take all my electronics from me and if I wanted to use them she had to be present and see watch me. There were other instructions that were given to me. Which I have proof of from an email. Since I had repeated sex from with my boyfriend, I had to be checked for STDs / Aids, you know, sexual diseases when I got to California. When I was seeing my boyfriend I was trying really hard to get pregnant because I did not want to go to California. He did not know what I was doing. I was meant to go to Cali late July but since everything, it moved up.

I was to be checked if I ~~was~~^{was} pregnant. I had to wear 5" heels and up, I had to wear really short skirts that showed my butt cheeks, the sheerest shirts so you could basically see my whole boob, walk naked around the house, and wash the cars naked outside. But I also had to drink alcohol and start eating meat again. I did everything, I even did my weekly walking in the mall for 2hrs with my

I also was told to watch porn and play with sex toys as I watched it. I had to watch porn once a week. I had to also drink coffee and when I drank alcohol I had to get buzzed or drunk and dance. A woman there who also was told to do certain things like me was the one helping me get the stuff and do it.

Eventually my sister came with Becky (Ernie's wife), and some instructions were given. I had to sleep with Becky, and we were supposed to have intercourse but that never happened. I was to sleep with her in the motor home until her husband came and took her place. I also was asked to be physical with his wife. Cuddle and love her at night.

Her husband came one week in June before he had to leave again for Jamaica to be with one of his other wives. During this time I was told I had to spend the night with every night that whole week until our marriage was consummated. We had to be and do everything

come at him. During this time I was being encouraged by family and other wives on how to please him sexually and that I needed to have sex with him or else my salvation would be lost. The first night he was with me. He was all over me. Rubbing me, touching my boobs, butt, vagina back, and overly cuddling me. I tried to cover up with blankets, my pillows, and stuffed animals. The next day I wanted to be away from him. He had a dream where I could not use all those items I mentioned above while sleeping. (considering the fact I was naked). From then on I kept being pushed to have sexual intercourse and oral with him.

In order to please people I had my sister come and show me the ropes to give Ernie oral. So she had gotten his penis erect for me to suck it. I was supposed to swallow his cum but didn't. Next morning I was awakened to him ripping the covers off me and asking if we could have sex, I said ok, it was like bam because that is when he is the hardest. He got on top put lube and started

This happened repeatedly during the week. There was a dream saying I had failed to fall in love with my husband because I was in love with another (my boyfriend). I was told I would be given another chance to go with him to Jamaica as our honeymoon in August.

I went in August to a resort called Hedonism II. It is a sex allowed nudists resort. I was to be there 6 weeks. During my time there I was to have sex with him constantly in public or in the room. I was told I had to just start sucking him when we would be talking to people or waiting in line for food or drinks. I was told I was to have fondle him and play with myself with my legs spread apart when I was by the pool or beach. I was told to wear skimpy clothing that went with the themes of the night and compete in the competitions. I went back home after my 6 weeks and was told I failed because I was still in love with another man. I was told I needed to apologize to

secretary of the ministry. I needed to say I sinned and committed adultery. I had to tell them I would work on being a better person, more loving & respectful toward elders. I did everything

I wanted nothing with the ministry at this point because they had taken all of my electronics again and told me I have to delete my facebook & end my friendships. And I did except with my boyfriend.

I was given another chance to go to Jamaica and prove my self. So his wife came and I took her place. I spent 3 more weeks there. Did the exact same things as last time. Came back home and I was not happy at all because I was told I had to stay in their house when I wanted to stay in mine. Things blew up and he had another dream saying I was possessed. That if I wanted to leave I could, if I wasn't going to keep the promises I made to God & him I had to leave because none

I was told I would lose my salvation and probably have to sell my body for sex to make money to survive by myself.

I tried to leave Dec 5, with my boyfriend's mom who came to pick me up. I couldn't leave with her and I made her leave without me. They both stopped talking to me after that because that was my last chance with my boyfriend.

Mom, sister, and Ernie came and picked me up from the airport, I was taken to mom's house. I regretted not leaving. I announced I did not believe in the dreams of God. A new dream came out that God would give me evidence to believe in the dreams. So demons & Satan were sent to the home. They were allowed to do whatever they wanted with me. I had no protection from God except that they could not kill me.

The house felt heavy from then on & I was afraid. We would hear weird noises at night and during

My room would have things thrown around several days it happened. Pillows would be thrown on the floor, popcorn & oranges would be thrown in the kitchen. Books thrown off the bookcases. In order to be forgiven I had to ask forgiveness from God, Ernie, and then ask him to remove the demon he commanded.

Eventually things got better but my dog Duke was threatened to get hurt if I didn't change. So everything went back to normal I went to staying with him but further instruction was given. I had to have anal sex with him, let him finger me, and perform oral & swallow. I didn't do any. I contacted my dad which was able to fix my boyfriend & me. His mom & my dad flew out to get me. I told them I had to leave before Jan 11. Because I was to fly out with Ernie to Florida, get a car, and drive back home. They picked me up on a Wednesday. I left with them and stopped all contact with everyone
